## **Recreation Committee:**

We've had or book, Bygone Days of Witless Bay printed for a 2<sup>nd</sup> copy. 300 were printed and to date over 200 books have been sold with requests coming in, and we expect more increased sales as the Come Home Year events get closer. The Council has purchased a few books as well to donate to the schools in the area and to the Center for Newfoundland Studies at Memorial University. The Committee is planning on having another 300 printed in time for Come Home Year so there should be lots available.

- d. Fire Department Liason Report
  - 1). During the pandemic Eastern Health had many volunteer Fire Departments including Witless Bay on limited dispatch for medical calls in order to protect the volunteers as well as the public. They recently contacted many of these departments to see if they are in a position to go back to full dispatch service and were notified that the Witless Bay Volunteer Fire Department are in a position to go back to full service.
  - 2) An update on the bunker gear the department recently purchased second hand in an effort to make their dollars go further: the department are extremely pleased with the quality of suits and all have been cleaned and put into service. There were two additional sets of gear provided at no extra charge with minor tears these were sent to a tailor to be repaired and put into service. As well the seller provided other equipment such as new boots at no extra charge.
  - 3) Since November of last year the department has had a major increase in applicants to volunteer. They currently have 4 new recruits going through the training process, and 6 more going through the interview process. These recruits bring the number of volunteer fire fighters to the department's highest levels in at least 7 years likely longer but this is the data I have right now.
  - 3). Myself and Jack Gatherall, with input from the department, recently designed a new logo that incorporates a lot of regular fire department imagery you'd see as well as imagery local to Witless Bay such as a Whale's tail in the center of the logo. We hope to unveil this to the public soon.
  - 4) In the first quarter of 2022 the Fire Department had 50 calls from January 1 to March 31 and this will put them on track to answer more than 200 calls in 2022.
