The complaint was brought forward at a privileged meeting of Council on April 25<sup>th</sup>, 2024.

At that meeting, Councillor Carey was given an opportunity to make a presentation to Council and when his presentation concluded, he left the meeting.

AND WHEREAS, at the privileged meeting on April 25, 2024, Council resolved and determined that Councillor Carey did not act while in a conflict of interest, in contravention of the Municipal Conduct Act:

- Disruption to the natural state of the land is to be minimized and any disturbed land is to be reinstated.
- 6. Installation of a 30ft long, 24-inch-wide culvert at the entry point from Dean's Road and a 20ft long, 18-inch-wide culvert at the intersection of the Reid Railway and the temporary road on the north side of the railway.
- 7. Installation of a stop sign at each location where the Reid Railway intersects with the temporary road.
- 8. Remove all culverts and signage when the water testing is completed and also reinstate the berm.
- 9. The development permit is valid for one year from the date of issue.
