Councillor Lucy Carew added that under direction from Municipal Affairs & Environment, Council was informed that the per capita for the Town's Own Source Revenue was below the required level based on the 2016 census report that compared population stats from 2011 to 2016. This generally occurs when there is a spike in population, such as what Witless Bay experienced from 2010 to 2015 with new subdivision builds.

Council submitted proposals to the Department of MAE in an attempt to avoid an increase in the mil rates for 2020 which is what will be required to bring the Town's Own Source Revenue to the required per capita level but unfortunately the Department of MAE was not in agreement, and increases in mil rates for 2020 is the only option. The increases will include:

Residential property mil rates will increase from 4 to 5; Minimum property taxes will increase from \$500 to \$550 Vacant land taxes will increase from \$150 (minimum per parcel) to \$200 Minimum Business Tax rate will increase from \$250 to \$300

In order to offset the mil rate increases, the Town will be offering a higher early payment discount rate of 8% and will extend this early discount period to May 31 on residential property taxes for 2020 instead of March 31 as in previous years. This will be the only discount offered as the Guaranteed Income Supplement discount of 5% is discontinued. No discounts will be offered after May 31.
