After this, members of Council will be invited to consider the Commissioner's recommendations, and suggest the revisions that are deemed necessary. Once this is done, the final version of the Plan must be approved before it is forwarded to Municipal Affairs for registration. Once it is Gazetted, it will immediately be in force.

(2) The East Coast Trail Association recommended that we include the language that Logy Bay has in its Plan: "The Council is committed to the maintenance of a buffer along the trail to protect the natural landscape and views from the trail and to ensure that future development doesn't negatively impact the trail."

PUBLIC OPEN SPACE IN SUBDIVISION DEVELOPMENTS

(Council also asked that it be made clear in the Plan that if Council accepts money in lieu of land, this money is to be used for the purchasing of land dedicated to public open space or of equipment to be used on land dedicated to public open space (such as playground equipment, for instance). **Motion carried unanimously.**

k. Development/Control Officer – Progress Report

Last month, Council decided to take the next step toward creating the position of a Development Control Officer by inviting other towns to partner in the initiative and to approach government for a possible funding assistance. We have sent an invitation to four nearby towns, and have a meeting for the end of the month to discuss.

I. Application to extend culvert on 37 Country Path Drive - Public Works consulted with the Towns Engineer and his recommendation was to keep open space in culverts.

Ralph reported that in conversations with Municipal Affairs it was confirmed that the key word council must abide by are their current roads standards that state all developments must front on a currently maintained public road.

Sebastien said that if the Town take this on it would be a costly venture for one person to build a house and that other roads with more residents living on them would be more of a priority. The applicant would have to pave a very short road whereas council would have to pave the entire road. It should also be noted that the applicant has access to his property from Harbour Road. He said Municipal Affairs and other towns confirmed that every other municipality has the applicant pay the cost of bringing the road to town standards. Sebastien also said the applicant could have a one way road. Sebastien returned to the chair at 8:40pm.
